Tranche 1 Placement Completion and Section 708A Notice

Mako Gold Limited ACN 606 241 829 (ASX:MKG) (Mako or Company) confirms the issue of 70,747,704 fully ordinary shares pursuant to Tranche 1 of the placement to sophisticated and professional investors announced to the market on 1 May 2023.

The total Placement comprises of the issue of c.86.7M new fully paid ordinary shares in Mako at an issue price of \$0.03 per share as follows:

- Tranche 1 Placement, comprising 70,747,704 New Shares (~\$2.1M), within the Company's placement capacity under ASX Listing Rule 7.1 ("Tranche 1 Placement"); and
- Tranche 2 of the Placement comprising up to ~15.9M New Shares (~\$478k), will be issued subject to Shareholder Approval at a General Meeting (General Meeting) proposed to be held in mid-late June 2023 ("Tranche 2 Placement").

Mako will also issue one (1) attaching unlisted option (**Placement Options**) for every two (2) New Shares issued pursuant to the Placement. The Placement Options will be exercisable at \$0.05, each with an expiry date 24 months from date of issue, and will be issued subject to shareholder approval at the General Meeting.

Settlement of Tranche 1 of the Placement has now been completed. Settlement of Tranche 2 of the Placement is expected to be completed on or around mid-late June 2023, subject to prior Shareholder Approval at the General Meeting.

The 70,747,704 ordinary shares issued are part of a class of securities quoted on the Australian Securities Exchange. The shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act 2001.
