Answer: No – the entity has now completed an extensive drilling program which saw high cash payments in the last quarter that preceded the announcement of the Company's maiden JORC resource for the Napié project.

Answer: The funds remaining at the end of the quarter are sufficient to fund on-going operations while the extent of capital raising opportunities and requirements are investigated.
